#### Investment strategy

The Fund invests predominantly in deposits with credit institutions and debt securities, manages actively and has no benchmark to compare its results with The investment strategy envisages investment of the Fund's assets applying a conservative investment strategy with the aim to ensure a predictable growth of the value of the Fund's units with limited fluctuations.

The main investment goals are to increase the value of investments by realizing income commensurate with (or possibly exceeding) the levels of alternative lowrisk investments, while taking low risk, as well as providing maximum liquidity for investors. #### Liquidity

Upon redemption the amount of transaction is received after its registration in Central Depository AD, usually done by the end of the business day, following the day of order submission. Submitting Orders might be submitted every working day - orders, submitted before 16:00 h. on a business day, shall be proceed on the same day, and orders, submitted after 16:00 h. on a business day - on the next business day. The redemption order can be given in any DSK Bank branch, where the Fund is distributed, regardless of which branch units have been purchased from.




