Investment strategy

DSK Horizon 2040 invests in a globally diversified portfolio - mainly passive financial instruments (exchange traded funds, following indices), as well as units of mutual funds, managed by DSK Asset Management AD. The portfolio provides exposures to a wide range of asset classes, such as stocks, debt securities and money market instruments. The Fund follows the life-cycle strategy - the defined investment strategy related to the realization of the maximum possible income while assuming moderate to high risk, until the target date. As the target date approaches, the structure of the portfolio will gradually change so that the part of low-risk and liquid instruments predominates. The fund is actively managed and has no benchmark to compare its results with. Detailed information on the financial instruments that can be included in the Fund's portfolio can be found in the Rules and the Prospectus.

Liquidity

Upon redemption the amount of transaction is received after its registration in Central Depository AD, usually done by the end of the business day, following the day of order submission. Submitting Orders might be submitted every working day - orders, submitted before 16:00 h. on a business day, shall be proceed on the same day, and orders, submitted after 16:00 h. on a business day - on the next business day. The redemption order can be given in any DSK Bank branch, where the Fund is distributed, regardless of which branch units have been purchased from. The investor may place a redemption order in any of DSK Bank offices where the Fund is distributed, regardless which office he has purchased the units at.


· seek to exploit the potential of more significant market changes in the value of equity instruments when there is more time before the assets are used;
